



## Important Pre-Hunt Information

*Herewith some important information and a summary of documentation that is required, in order for Sommerby Safaris to provide a well organized and hassle free Safari experience when it comes to your paperwork.*

### **Safari Documentation**

Our office will supply the following documentation to you via email (please make sure it is completed, signed and sent back as soon as possible):

- Safari Contract
- Indemnity Form
- Client Info Form

### **Rifle Importation**

A temporary import permit from the South African Police Service is required to bring your rifle into South Africa. We will apply for the permit on your behalf by completing the SAP520 form. All that we need from you is the following information:

- Contact Details
- Detailed description of Rifles and ammunition
- Customs declaration Form 4457\*
- Flight Itinerary
- Copy of Passport

To obtain a Customs Declaration Form 4457, you need to take your rifles to your nearest US Customs Office. Please note, you should call to make an appointment and make sure you have the form STAMPED.

**NB: The US and South African governments have recently changed regulations about 4457 documents. Documents HAVE to be issued in the year of travel (stamped) and an expiry date needs to appear on the document. Many people are still under the impression that these documents do not expire. THIS IS INCORRECT. Please ensure that your document does not expire before or during your safari, to make sure that there are no problems in obtaining your temporary rifle import permit. Remember to bring the original with you.**

Please see after this document examples of a VALID and INVALID 4457 customs document.

### **Trophy Exportation:**

The field preparation and care of our clients' trophies is a TOP priority at Sommerby Safaris. Trophies have to undergo a Dip & Pack process to be shipped raw and mounted by a local taxidermist in the USA. They can also be mounted in South Africa prior to shipping.

Herewith an **estimated** cost for Dipping, Packing and Shipping a crate containing 7 Trophies:

Raw Prep	7 x Trophies @ \$100 each – Dip and Pack	\$700
Documentation & Crating	Once-off fee	\$445
Airfreight & Shipping	7 x Trophies @ \$120 each	\$840
